Are there services covered before you meet your deductible ?	Yes. Prescription Drugs and Preventive care for In- Network and Out-of-Network Providers and telemedicine visits with Live Health Online.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
